FFI is a regime implemented by the HSE on 01 October 2012 in order to aid cost recovery.

HSE inspectors now charge £124 + VAT per hour for any time spent investigating businesses for material breaches in UK Health & Safety legislation.

Lighthouse can provide an indemnity guarantee, reimbursing any FFI costs levied at your business up to £10,000 per incident and £25,000 per annual period.
